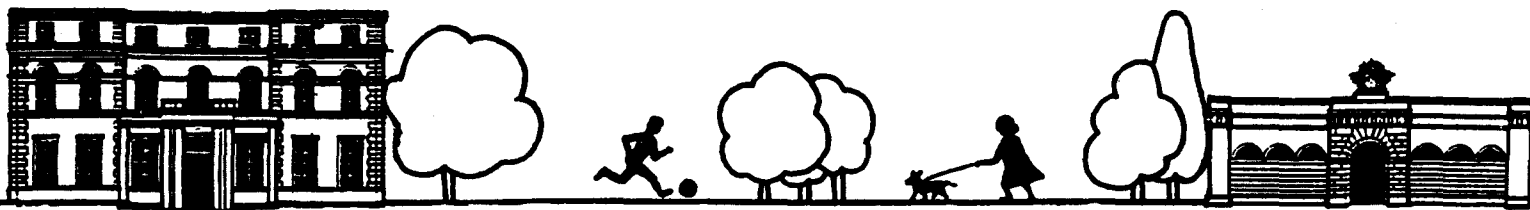

## HORSES, CHILDREN AND CARRIAGES?

In this Newsletter you will find the Draft Planning Brief on which LB Hounslow's Environmental Planning Committee wants your comments by 2nd December.

You will remember that, when LB Ealing and the Gunnersbury Park Joint Committee together "won" the Arbitration, the only way the councillors from Hounslow could stop it progressing was to suggest getting a Planning Brief drawn up for the site. Ealing disagreed; Hounslow said that as it was the planning authority, it would go ahead anyway. This is the result.

At the last GP Joint Committee the Hounslow councillors declared that they had half the money for this scheme, but they would not say where it had come from, nor how much the scheme would cost. They insisted that the Ealing councillors find the other half! When Ealing's councillors demurred, the Hounslow lot waved their fingers, banged the table and declared that they were the only ones to take the Park and its problems seriously!

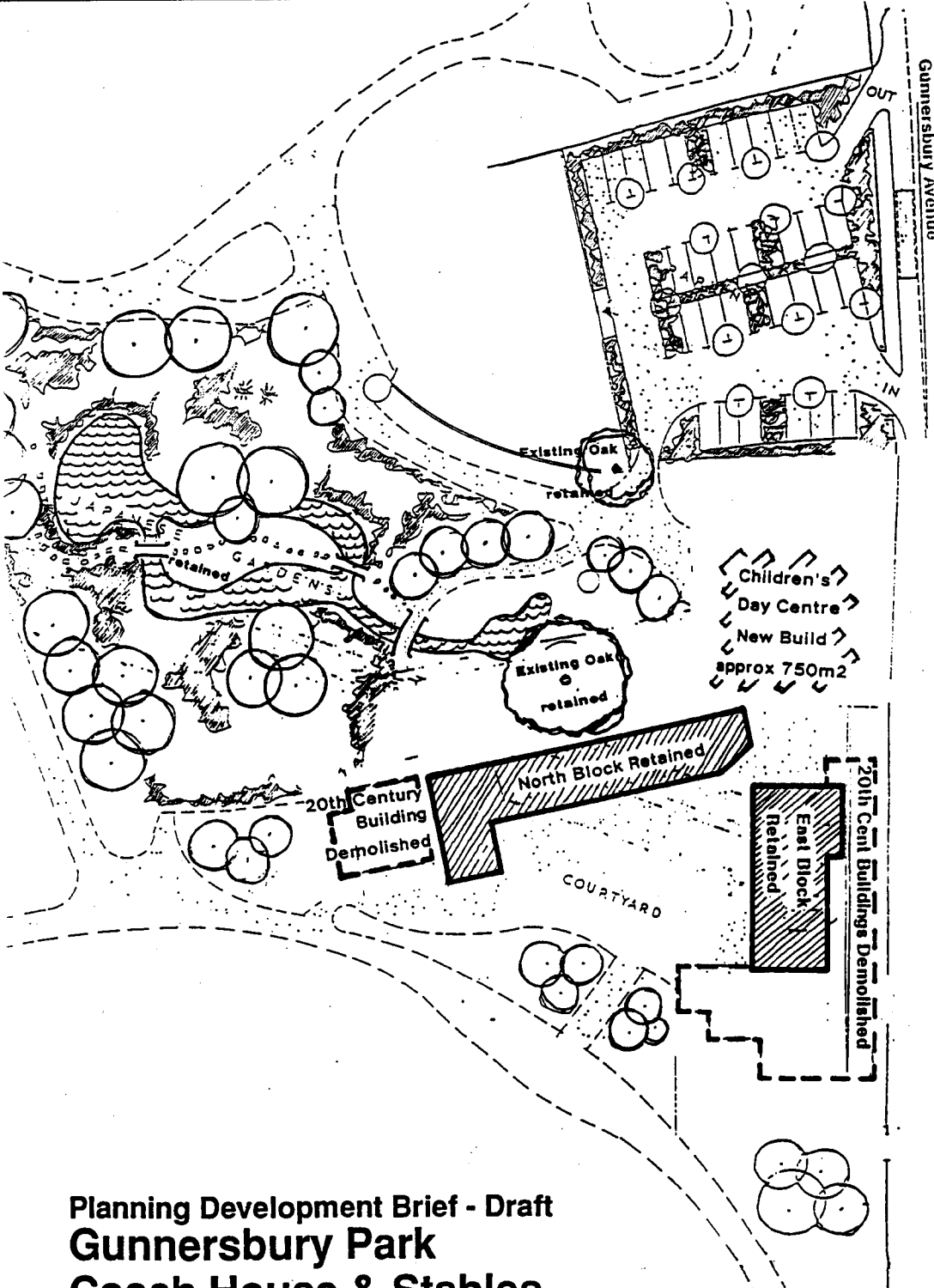

GUNNERSBURY PARK  
COACH HOUSE AND STABLES  
PLANNING BRIEF

LAND USE (See attached Plan)

The Coach House (North Block) and the Stables (East Block) are mid-nineteenth century Grade II and II\* listed buildings, located within the Grounds of Gunnersbury Park.

The Coach House (North Block)

To be retained and renovated for use as an annexe for the Transport exhibits in the large mansion, using both floors, with twentieth century buildings attached to the coach house to be demolished.

The Stables (East Block)

To be retained and renovated for use as a riding facility. This should include:

- (a) The provision of a Riding area to be located towards Kensington Cemetery.
- (b) The provision for ancillary facilities, for example, hay storage, within existing buildings or by means of new build.

The twentieth century buildings attached to the Stables to be demolished.

The provision of a 750m<sup>2</sup> (approximate) new building to be located on land between the North Block (Coach House) and the proposed car park, for use as a Childrens Day Centre.

To include:

- (a) The adaptation of part of the Japanese Garden for use as a Day Nursery open space.
- (b) The provision of a landscaped car park with 30 spaces to be located on land to the east of the Japanese Gardens.

ACCESS FOR DISABLED

Development must comply with the BS1 Code of Practice 'Access for the Disabled to Buildings' (BS5810: 1979) and Access for Disabled People: Part M. The Building Regulations 1985. In particular there should be satisfactory access for the disabled to the public areas within the site.

DESIGN AND LAYOUT

A good quality of design and materials should be used for the new building, to complement the design and materials of the existing buildings and to respect the setting of the listed buildings.

The height and scale of the proposed new building should not exceed that of the existing building's.

Specific items for conservation and environmental enhancement of the site to include:

- (a) Retention and Renovation of existing Stables and Coach House buildings.
- (b) Demolition of existing 20th century buildings.
- (c) Restoration of Japanese Gardens.
- (d) Retention of the two mature oaks (as shown on attached plan).
- (e) The retention of the boundary wall between the access points to the proposed car park.

ROAD LAYOUT, ROAD IMPROVEMENTS, VEHICLE ACCESS AND PARKING

Access to and from the site shall be from Gunnersbury Avenue. Road layout to be designed so as to have separate access and egress points. The access points to be designed so as to retain the character of the boundary wall.

Necessary road improvements or alterations to provide vehicular access from Gunnersbury Avenue to be agreed with the Local Highway and Planning Authority and the Department of Transport.

Vehicle parking to be provided to the Council's standards.

GENERAL

This brief is to be read at all times in conjunction with attached plans, showing land uses and vehicle access arrangements.

This brief is also to be read in conjunction with the Council guidance on Child Care provision contained within the document 'Quality Child Care'.
